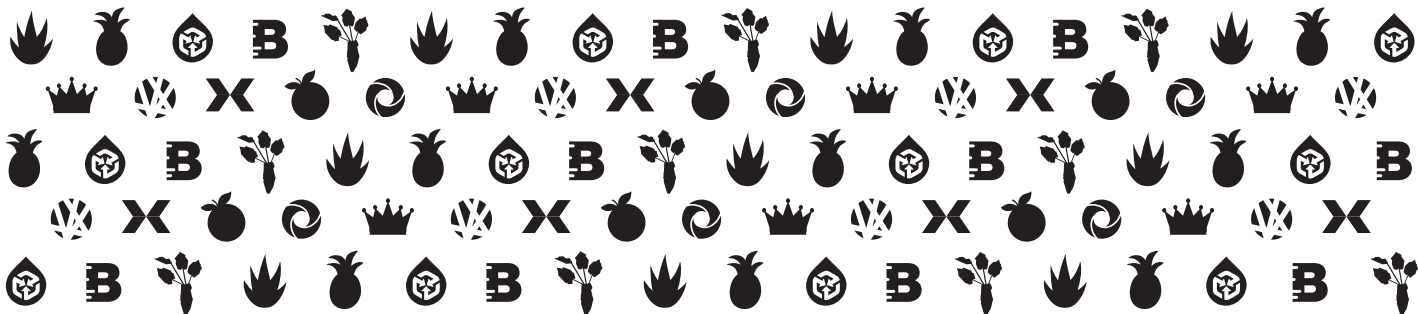
Method of administration: Remove the cap, insert the dispenser into a nostril and nebulize 1 or 2 sprays while breathing in. Repeat the operation in the other nostril. At the end of each use wash the dispenser with hot water, dry and refill the cap. At the first use press several times the dispenser outside the nostrils until a uniform spray is released. Use 3-5 times a day or as needed, taking care not to spray it in the eyes or mouth.

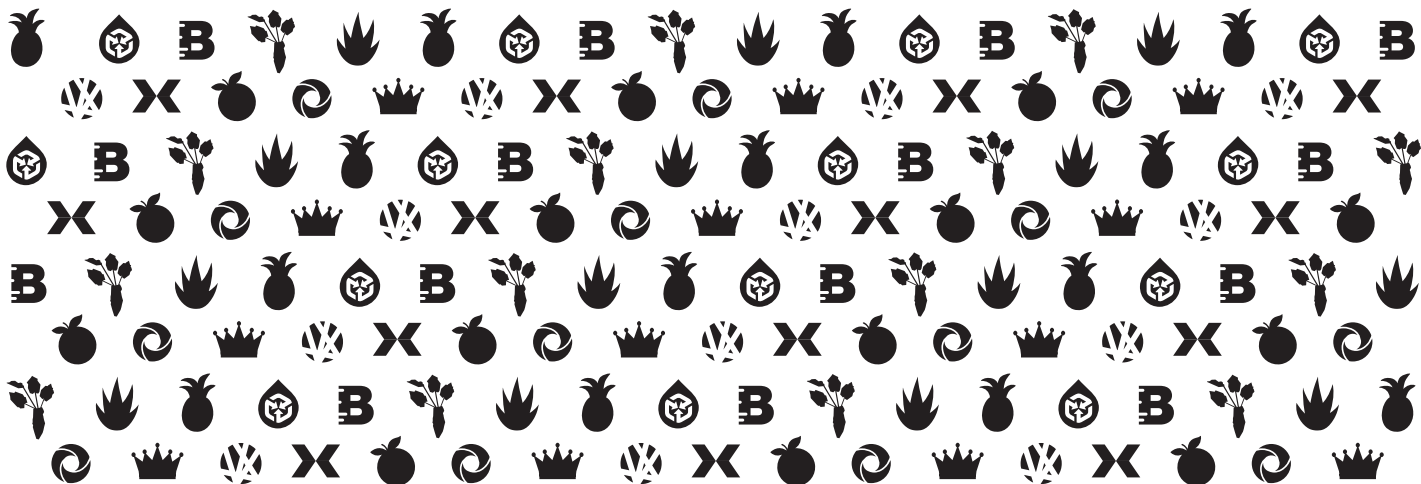
